

Access to the Labour Market for Refugees with an Aufenthaltsgestattung or a Duldung

General Information:


Do you have a « Aufenthaltsgestattung » (temporary residence permit) or a « Duldung » (temporary suspension of deportation)?

Do you want to start a new job, vocational training or an internship?

You always need permission from the **Foreigners' Registration Office** (Ausländerbehörde) for any employment.

In the first 4 years in Germany, the **Federal Employment Agency** (Bundesagentur für Arbeit) must also give its approval in many cases.

How do I apply for a work permit?



Labour bans (and exceptions) for people from 'safe countries of origin:

Albania, Bosnia-Herzegovina, Georgia, Ghana, Kosovo, North Macedonia, Montenegro, Republic of Moldova, Senegal and Serbia

Do you come from a so-called 'safe country of origin': *Albania, Bosnia-Herzegovina, Georgia, Ghana, Kosovo, North Macedonia, Montenegro, Republic of Moldova, Senegal and Serbia? In this case, you are generally banned from working. Exception: You come from the Republic of Moldova or Georgia and have

- left the initial admission centre and
- applied for asylum by 30/08/2023 or
- stayed in Germany on that day (30/08/2023) without applying for asylum

Further bans in case of a Duldung

- In the case of a "Duldung" for persons with an unclarified identity (§ 60b AufenthG)
- If deportation is not possible for reasons for which you are responsible
- If you are only entering the country because you are receiving benefits under the Asylum Seekers' Benefits Act (AsylbLG)

Who receives a Duldung according to § 60b AufenthG?

Especially people who

- refrain from attempting to obtain a passport and <u>therefore</u>
- cannot be deported


